- Relevance of the resources;
- and other necessary elements.

The study program has been prepared through the consultations with essential educational stakeholders/participants, in accordance with the labor market demands, according to scientific and educational standards and achievements and according to Standards and Norms for performance of activities of higher level of education at the area of Una-Sana canton. The faculty is in possession of the resources needed for implementation of the study program and the objectives and teaching outcomes of study program are comparable with the same and/or similar programs of other university level academic institutions.
